

# GET READY FOR SIMPLER RECYCLING

## What is Simpler Recycling?

Simpler Recycling is a UK-wide legal framework developed to make the recycling process more straightforward. The main intention of the framework is to create consistency in the waste and recycling materials collected from households and businesses.

The legislation outlines a core set of materials which must be collected, to remove current national recycling scheme inconsistencies and help the UK hit their recycling rate target of 65% by 2035. Recycling these items are not only beneficial to the environment but more cost effective than simply disposing of them, meaning this is a win-win for businesses.

## What are the changes, and what do they mean for Recorra customers?

### Mandatory Recycling

All businesses must recycle food waste, glass (if producing any), rigid plastics, metals (cans), cartons, paper and cardboard.

Clean and dry plastics, metals and cartons are collected in Mixed Recycling, along with paper and cardboard if these are not being segregated.

### Paper and Card (fibre)

Separating paper and cardboard is preferable. If you would like to set up paper and cardboard collections, contact your Account Manager today.

Customers recycling paper and cardboard in their Mixed Recycling will also remain compliant thanks to our state-of-the-art MRF where we separate paper and card from other recyclables. We have completed TEEP assessments on our customers behalf, if you would like a copy for your own records simply contact our helpdesk.

### Food

All businesses must recycle food waste.

### Glass

All Recorra customers must have a separate glass collection (if you produce glass).

## In a multi-occupancy building?

For customers within multi-tenanted buildings, it is each business' responsibility to remain compliant with legislation and ensure these materials are recycled. This means each occupier will need bins for mixed recycling, food waste, paper and card (if segregated) and for glass if their business produces glass.

# Getting Simpler Recycling ready

## Mixed Recycling

Mixed Recycling includes recyclable materials such as metals (cans), rigid plastic, paper and card (if not recycled separately) and now cartons, in a singular waste stream to be processed. Your recyclables should be clean and dry to avoid contamination.

Most businesses will already have Mixed Recycling collections set up, but you must ensure all items listed are collected.

Aluminium can be collected with mixed recycling. This includes aerosols, steel and aluminium jars and bottle lids, and aluminium foil and food trays.

## Paper and Card

Paper and cardboard (fibre) should be collected separately to Mixed Recycling, where practicable. This is to avoid potential contamination of fibres from food and liquid residue in mixed recycling.

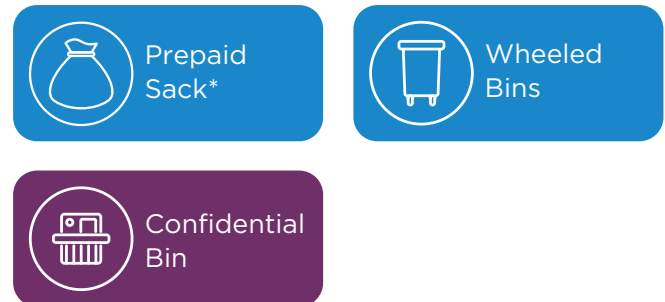
Recorra already provides separate collections for paper and card. If you can only segregate one stream, we recommend segregating paper as these fibres are less durable.

### How do we collect Mixed Recycling?

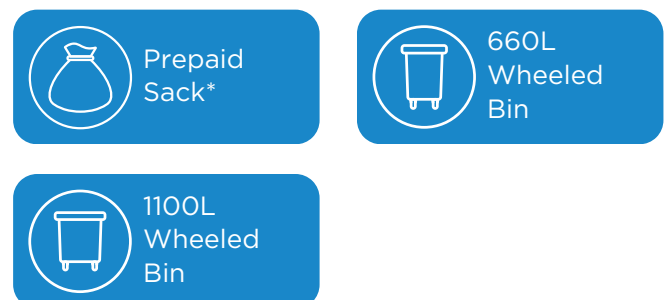

# Getting Simpler Recycling ready

## Glass

We collect and recycle glass, whatever the colour. We collect glass as a separate waste stream, so customers will need to set this up (if they produce glass) to remain compliant with government legislation.

As a rule of thumb, we advise setting up collections if you produce 5 or more bottles per week. Collections can be undertaken on either a scheduled or ad-hoc basis.

For health and safety reasons, please place your glass directly in your crate or bin. We do not accept sacks within crates or bins.

## Food Waste

From March 2025, separate food waste collections will be mandatory for businesses. Many customers will already have food collections but use this as an opportunity to re-educate your staff about the importance of food recycling.

We provide food waste recycling to suit the needs of any business and have a range of collection methods for any business, big or small.

Bin exchange services are also available meaning that food bins are collected full and exchanged with clean, washed empty bins. They are emptied and washed, back at our facility after each collection. We also offer a hybrid service where bins are only exchanged once per fortnight or month, to keep costs down but also periodically giving you new bins.

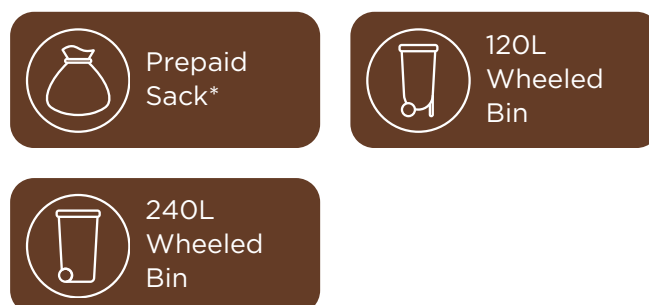
For every food waste collection we complete, Recorra donates the equivalent of one meal to our charity partner Plan Zeroes, who helps businesses donate surplus food to communities in need.

### How do we collect Glass?



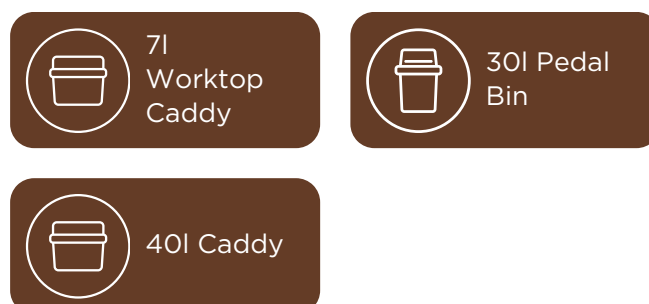

# Getting Simpler Recycling ready

## Circular Box

From March 2027, businesses will be required to recycle flexible plastics. These plastics are soft plastics that can bend without breaking, commonly used in packaging, consumer goods, and medical devices due to their durability and adaptability.

It is not yet clear whether flexible plastics will be collected separately or mixed together; once the government gives us clarity on this, we will adapt if needed and inform our customers in due course.

The Circular Box was created to capture your hard-to-recycle items, such as flexible plastics, and so is the ideal service to stay compliant with changing legislation. We deliver your box to your workplace and collect it directly from your office once full.

## How do we collect Flexible Plastics?



To allow us to recycle as much as possible, we collect one material per Circular Box.

## Bin Sacks and Liners

For all of our stream and collections, we have colour-coded sacks.

Order your corresponding bin liners when setting up your collections. These are required for all streams, except glass. Glass bins should not have a liner.

Our bin sacks and liners are available as:

- Biodegradable sacks for food caddies
- In-office 40L plastics sacks to line 40L bins
- 120L plastic sacks

# Getting your workplace ready

These changes come into force for all businesses with 10 employees or more across the company. This means that if your business has 2 sites and 5 employees work at each, making a total of 10, each site will have to comply with Simpler Recycling. For businesses with fewer than 10 employees, Simpler Recycling will come into force 31st March 2027. We advise you get compliant as soon as possible.

Follow our 3-step guide to getting Simpler Recycling compliant.

## Step 1 - Review your waste services

Evaluate your waste streams to check whether you have all the services required. Remember segregated food collections are mandatory and consider whether it is possible for you to segregate paper and card. ## Step 2 - Check your binrastructure

Undertake a review of internal binrastructure and posters, ensuring that your staff can dispose of all the core waste streams. You can browse our suite of internal bins [here](#) and updated bin posters [here](#), we recommend printing them and placing them around your workplace.
